Maddox Topliff, Wamego High School Student Council President and Nora Bosse, Vice President, were present to request approval for a homecoming parade on September 27, 2024, which will close Lincoln Avenue from 12:45pm to 2:00pm. Commissioner Jacobs moved, seconded by Commissioner Faulkner to approve the parade request. Motion carried. Aye: 5, Nay: 0.

Oztoberfest and Porches on Polar Requests:

Tegan Kreider and Eric Artzer were present to request the closure of Ash Street from 5th and 6th Streets for the annual Oztoberfest. The event would close Lincoln Avenue from 4th to 8th Streets, 5th Street to the west and east of Lincoln Avenue. She advised that the intersection of 6th Street and Lincoln Avenue would be closed for emergency personnel only. Commissioner Jacobs moved, seconded by Commissioner Faulkner, to approve the Oztoberfest plan. Motion carried. Aye: 5, Nay: 0. Tegan then requested permission to host the Porches on Poplar event on Poplar Street from 4th to 6th Streets, allowing the wine and beer samples to allow the participants to walk from porch to porch. Mayor Weixelman re-appointed Matt Totten to the airport board.

Project Updates and Change Orders:

Stacie reported that the street project is moving along with Vine Street open, Chestnut should be partially open by the end of September and fully open by the end of the year. The side streets should be open prior to the closing of Spruce. There are no purchase requests.

City Manager and Other Reports - City Manager

The City Manager advised that all departments are doing well. The plan is to stay open on the weekends until Labor Day contingent on staff availability, there were several aquatic staff compliments in the past couple of weeks. The splash pad will stay open for a few more weeks. With the newest police department hire, the police department has no open positions. There will be an open house at the fire department in the fall, the commissioners saw the new fire truck outside of the city office during the work session. The power plant picked up running during the last round of severe weather.
