Special Meeting:

The Governing Body of the City of Wamego, Kansas, met in a Special Session on Wednesday, September 04, 2024, at 6:00 P.M. in the City Commission Chambers at 430 Lincoln Avenue, Wamego, Kansas to meet with the library board members. Those present were Commissioners: Dwight Faulkner, Michele Jacobs, William Ditto, Clifford Baughman and Mayor Richard Weixelman. Library board members present were Carol Conwell, Claudia Leeds, Dana Wethington and Board Secretary Stacy Slagle, Vice-Chair Brad Ross and Board Chair, Alisha Paddock.

The City Manager, Stacie Eichem, City Clerk, Shanda Jahnke, City Treasurer, Leslie Dugan, and Jake Pugh, City Attorney, Library Director, Darci Hildebrand were also present.

Library Board Chair, Alisha Paddock, requested an amendment to the agenda. She requested an executive session relating to non-elected personnel be held with the library board and city commission.
